The 2,620,024 shares reported as directly beneficially owned by Farmer Equities, LP ("the Partnership") were previously reported as beneficially owned by Carol Lynn Farmer Waite, Jeanne Ann Farmer Grossman and/or Richard Francis Farmer as trustees, beneficiaries and/or settlors of various family trusts on Form 3/A filed with the SEC on March 14, 2005. The reported shares are rounded to the nearest whole share. The Partnership acquired direct beneficial ownership of the 2,620,024 shares on December 14, 2005 when they were contributed to the Partnership by various trusts for the benefit of the Farmer family. No shares were purchased or sold. See the Form 4 filed as of the date hereof by Carol Lynn Farmer Waite on behalf of herself, Ms. Grossman and Dr. Farmer.

2. The 2,620,024 shares contributed to the Partnership are also indirectly beneficially owned by the Carol L. Waite Trust, dated August 26, 1997, the Jeanne F. Grossman Trust, dated August 22, 1997, and the Richard F. Farmer Revocable Living Trust, dated December 29. 1995, as general partners of the Partnership. Each general partner disclaims beneficial ownership of these shares except to the extent of its pecuniary interest therein.

4. Directly beneficially owned by the Richard F. Farmer Revocable Living Trust, dated December 29, 1995.
